



Health Guarantee & Deposit terms

The Buyer certifies that he/she is buying this dog for him/herself, to keep, nurture and cherish for the entire lifetime of the dog, and is not acting as an agent for another party.

The Buyer agrees to take good and reasonable care of this dog, feed and house the dog properly, and promptly to give or secure the best of attention to the dog's physical welfare.

No guarantees of any type are offered or implied by this contract except those that are specifically so stated. No money will be refunded in whole or in part.

This dog is sold in good health with all vaccinations current. If a veterinarian issues a written statement stating that the dog is not in good health, the dog may be returned to the Seller within forty eight hours of the time of receipt and the Seller will replace the dog with another of approximately the same quality and sex as soon as one becomes available.

This puppy is guaranteed for one full year for life-threatening congenital defects.

If there is found to be one of these defects the puppy must be returned before a replacement can be made. Buyer must give statement from vet stating the defect. If a puppy must be replaced it will be replaced with the next available same sex pup of the same quality and the total expense of shipping will be paid by the buyer. If the puppy must be shipped it will only be shipped counter to counter with the buyer paying the cost of shipping, crate and health check. This guarantee is void if the puppy is resold. If buyer decides to not return the puppy this contract is void.

This guarantee does not cover what we in the BULLDOG breeds consider normal: Cherry eye, entropion, ectropion, "loose" hips or knees, allergies, soft palate issues, trachea issues, stenotic nares, inverted tails, fertility issues, parasitic, fungal or bacterial infection, respiratory infection ect. Buyer understands that bulldogs are special and that special consideration must be given if buying one of these breeds. We will not cover death if your pup has been put under (surgery ect, and has died). Putting a Bulldog under requires a skilled and knowledgeable vet.

All items covered by this guarantee are replacement only. You must return affected pup to us and we will replace him/her. WE DO NOT GIVE REFUNDS!!!

Seller is not responsible for medical expenses incurred. Buyer is aware that owning a pup means trips to the vet and bills. Buyer understands he/she will be responsible for ALL the vet bills. Pup has been vet checked prior to leaving us and found to be in good health.

As of the date of delivery, your pup will be current on vaccinations and de worming. The buyer has been informed of this. Buyer is aware puppy will need more vaccinations and de worming and agrees to provide these. Buyer understands that though his/her pup is current on the shots, more are needed to provide immunity to disease.

Buyer is responsible for all shipping costs UNLESS stated otherwise. Pup must be paid in FULL before it leaves us.

Pup is guarantee against Parvo Virus and Distemper for 48 hours upon arrival to your home.

Although the puppy is vaccinated this guarantee does not include coccidian or kennel cough, both of which can be common in puppies. Kennel Cough is usually self limiting. Full recovery is expected and on its own is not life threatening. We do not guarantee internal & external parasites, loose stool, coccidia, giardia, or any condition that can be corrected by a veterinarian.

We do not guarantee against Parvo, Distemper, Adenovirus, Para influenza and Bordetella, no guarantee is given against these diseases due to their unpredictable nature. Seller is not responsible for any vet bills once the new owner takes possession.

Addition terms: Any puppy going to a new home may be a bit unsure of themselves until they are comfortable with their new surroundings. The buyer was cautioned to be careful when introducing the puppy to other family pets and members until they have been well socialized.

We offer lifetime return policy of our dogs. If for a valid reason a buyer can no longer keep the purchased dog the seller shall agree when ever possible to take said dog back from buyer and try to find it a good home. This does not imply the return of any monies. This is done on a case by case basis. Pup will be re homed.

There are no refunds on Deposits, unless otherwise agreed here in writing. Failure of the Buyer to complete this purchase would subject Seller to lost opportunities to sell the Puppy to some other Buyer and retention of the Deposit is meant to compensate Seller for his possible loss. This deposit signifies the intent on the part of the Buyer to follow through with the Purchase of this Puppy.

The Seller reserves the right to void this transaction and refund the Deposit if we learn of any reason why Buyer might not be suitable for the puppy –(i.e. Buyer is found to be an animal abuser, violent person, representative of a Pet Store, representative of a pharmaceutical research laboratory etc.) .

If the transaction is voided or if through some tragic accident the Puppy were to die or otherwise be seriously injured before it goes to its new home then, of course, the deposit will be returned to the Buyer; unless the Buyer wishes to apply the Deposit to another Puppy, if one is available, or to a puppy from the next available litter.
